FOLLOWING the several complaints received regarding the trip to and from the Island Garden City of Samal (IGACOS), the 9th Sangguniang Panlalawigan of Davao del Norte, led by Vice Governor De Carlo "Oyo" Uy, immediately took action.

Certain ferry operators were summoned during the question hour of the 4th Regular Session held on July 25, 2022. Mr. Wesley Bangayan, President of DAVSAM Link Corporation, and Mr. Archie O. Dumayas, representative from MAE WESS, Co. were invited to inform the Sanggunian on the commonly-encountered concerns of commuters from IGACOS to Davao City and vice-versa, including the three to four hour wait just for the passengers to cross from and to the island. After hearing about the transportation situation, the Sanggunian Panlalawigan laid out recommendations to alleviate the ordeal

of the long line of passengers.

One of the recommendations of the legislators is for the operators to write a letter to the provincial government, particularly the governor and the Provincial Council through the Office of the Vice-Governor, requesting to consider the opening of the property of the Provincial Government in IGACOS that is currently occupied by the Provincial Engineering Office (PEO). "Giistorya nato ang duha ka operators unsay maayong mahimo nato nga temporary nga solusyon niani, pending wala pa ang bridge. Gipa-formalize nako sila paghatag og letter kay naay existing property ang provincial government tapad sa dock sa Mae Wess nga pwede pud siya magamit, but naa poy mga considerations as to cost and budget. But amo na lang sa ipapasa og formal na letter kay reviewhon dri sa Sangguniang Panlalawigan together with the executive department para ma-address nato ning dako kaayo na concern karon sa mga lumulupyo sa Island Garden City of Samal," Vice Governor Oyo Uy said in an interview.

Mr. Bangayan revealed that the primary concern is the port in Samal where only one ferry can dock due to strong waves when there is a ferry arriving. He added that due to the strong waves, it is not possible for two ferries to go at the same time, which is why he suggested that the port used by the Provincial Engineering Office in Davao del Norte be opened in that area to serve as a docking area for cargoes. With this method, the operator said that ferries can travel faster and trim the long lines in Davao City. The PEO port in Samal still needs to be rehabilitated so that it can be used as a port for ferries.

Apart from the port of Samal, the

Sanggunian Panlalawigan also suggested to the operators to ask the Philippine Port Authorities (PPA) to open the exit point because the traffic will be congested in the narrow passage and to implement a "system". Through a system, vehicles will be organized accordingly since the motorists and passengers already know their boarding schedule. Also included in the discussion is the regular safety checkup and maintenance to ensure the safety of the passengers. Vice Governor Oyo Uy also probed if the various concerned government agencies regularly conduct safety check-ups of the ferries.

Subsequent to the conduct of the 4th Regular Session, Vice Governor Oyo Uy, together with Mr. Bangayan, Mr. Dumayas, and various concerned government officers, convened for a meeting on August 2, 2022 at the Sangguniang Panlalawigan (SP) Conference Room. In the interest of having an immediate resolution on the matter, the body decided to settle on the submission of a proposal coming from MAE WESS, Co. which will be subjected to evaluation by the Provincial Government of Davao del Norte. The proposal will have to include their plans for the wharf, as well as their demands on the part of the government. The Provincial Government will wait for the proposal as the latter will be discussed with the executive and legislative bodies to formulate a counterproposal.

Concerns were raised as regards the Provincial Engineer's Office landing wharf in view of its dilapidated structure. Vice Governor Oyo Uy suggested the restoration of the wharf by MAE WESS, Co. to its intended function, considering that they will be utilizing the wharf for commercialization. Engr. Josie Jean R. Rabanoz, Provincial Administrator, emphasized that the proposal must be within a temporary timeframe pending the construction of the bridge. Once construction of the bridge commences, the commercial operations will have to be terminated. Vice Governor Oyo Uy further added to base their proposal within a timeframe of three to five years, good enough to recover the company's investment. Mr. Bangayan agreed to the proposal and he is planning to use the wharf to cater cargoes, buses, and maybe motorcycles. If possible, the loading area will be used for cargoes and the unloading area for cargoes

Moreover, Vice Governor Oyo Uy directed the body to look into existing Public-Private Partnership Ordinance in the province. Further, a Memorandum of Agreement may be entered into by the parties.

SP opens Term 2022-2025, Inaugural Session makes history

July 4, 2022 at 9:00am marked the first time in the Province of Davao del Norte's recorded history that the Sangguniang Panlalawigan (SP) held its Inaugural Session at DavNor Gym, Davao del Norte Sports and Tourism Complex (DNSTC), Mankilam, Tagum City, in lieu of its traditional venue at the SP Session Hall. This break from the decades-long tradition of conducting the term's opening session outside of the Legislative Building, is attributed to the proactive stance of the SP officials and visionaries. At the helm is the Legislative Department's head, Vice Governor De Carlo "Oyo" L. Uy, MBA, who spearheaded the planning for the historical event several weeks prior to assumption to office. The Vice Governor, together with the honorable ladies and gentlemen of the Sanggunian advocated for the strict observance of health protocols. Hence, it was unanimously agreed upon by the body to break status quo for the purpose of implementing the prescribed guidelines primarily on social distancing and venue capacity.

The Inaugural Session was called to order by Regular Presiding Officer, Vice Governor Oyo Uy. Hon. Robert L. So acted as Floor Leader while Senior Board Member Flopone Royle A. Catalan said the opening prayer. This also marked the first instance wherein the DavNor Capitol Choir members displayed their vocal prowess live in an Inaugural Session singing of the National Anthem and the Davao del Norte March.

Three (3) neophyte provincial law-makers were welcomed among the ranks of the SP, all three are no greenhorns to legislation – Senior Board Member Flopone Royle "Popop" A. Catalan, a former legislator from the Sangguniang Panlungsod of Panabo; Hon. Orly A.

Amit, previously, the Vice Mayor/Head of the Legislative Department of the Island Garden City of Samal; and Hon. Emmanuel "Mawe" G. Pamisaran – another former member of Panabo City Council who's reunited with his erstwhile colleague, Hon. Catalan, in the roster of newly-elected provincial officials. This term's set of reelectionists comprise five (5) legislators, four (4) of them hail from the 1st Legislative District: Hon. Francisco "Frank" C. Remitar, MDMG (3rd term), Hon. Nicandro "Nickel" T. Suaybaguio, Jr., UAP (2nd term), Hon. Prospero "Popo" E. Estabillo, Jr. (2nd term), and Hon. Robert "Tete" L. So (2nd term). Hon. Jannet "Taknet" N. Tanong-Maboloc of the 2nd Legislative District is now on her third (3rd) term of office.

Victorious in her first attempt at running for office, newly-elected Hon. Denise Marianne A. Lu, MD, retains her seat in the August chamber, this time as a full-fledged elective official. Veteran lawmaker, Hon. Shirley Belen R. Aala, also made a successful comeback in the halls of the Sangguniang Panlalawigan following the completion of her third consecutive term of office last 2019. Completing this term's roster are the sectoral representatives or the ex-officio members of the Sanggunian, namely, Hon. Dindo C. Parangan (Federation of Associations of Barangay Councils), Hon. Silvino "Jun" P. Matobato, Jr., PTRP (Philippine Councilors League), Hon. Ariel S. Macla (Indigenous Peoples Mandatory Representative) and Hon. Emerson Dave A. Silutan, LPT (Sangguniang Kabataan Provincial Federation President).

Aforesaid session served as the venue for the Executive Address of second-termer Provincial Governor, Hon. Edwin I. Jubahib who is popularly known by the moniker "Kuya Gob". In accordance with

Section 465 of the Local Government Code of 1991, the Honorable Governor presented his program of government and proposed policies to the SP on said occasion. The Provincial Governor highlighted that the eponymous "KUYA GOB" seven-point development agenda during his first term in the gubernatorial seat has been enhanced by inclusion of additional components and shall be updated to read as "KUYA GOB NG MASA". Further, the Honorable Governor expressed his gratitude to the SP for its support in the implementation of the plans and programs as well as in the crafting of the previous term's Executive-Legislative Agenda (ELA). He further emphasized his call for genuine inclusive growth and development to serve the best interest of the people.

Other notable personalities during the occasion include Mayors and Vice Mayors, Sangguniang Bayan and Sangguniang Barangay Members of component Local Government Units (LGUs) of the Province, Provincial Government Department Heads as well as the respective families of the SP Officials.

Two legislations were passed by the collegial body under Unassigned Business: Resolution No. 409 which adopted the new set of Internal Rules of Procedure (IRP) of the Sanggunian and Resolution No. 410 which adopted the Composition of SP Standing Committees for Term 2022-2025. Both resolutions were crafted with the changing needs of the Dabaonon people in mind.

After the adjournment of the Inaugural Session at 10:25am, official group photos of the legislative body were taken. This was immediately succeeded by photo opportunity (photo op) with the officials' families, legislative staff and other guests.
