VG Oyo marks first 100 Days with major achievements in social services

Focusing on his three legislative prime principles, namely: open, participatory, and empowering-providing more avenues where people can access social services, is one of Vice Governor De Carlo "Oyo" L. Uy's major achievements in his first 100 days in office.

He celebrated his 100th day in office with the residents of Brgy. Mesaoy, New Corella on October 10, 2022 during the second run of "Tambag Legal," one of his social services programs. This "Tambag Legal" program was initiated by the Vice Governor's Office in partnership with Integrated Bar of the Philippines (IBP) Davao del Norte-Davao de Oro Chapter and St. Thomas More (STMS) College of Law. The program aims to provide assistance to residents through legal advice and consultation. The program was initially launched on September 15, 2022 with 8 IBP lawyers, 2 STMS lawyers, 42 STMS law students, and 448 residents at Brgy. Pagsabangan, Tagum City, where 450 participants graced the event. While 514 participants attended the program during its second run at Brgy. Mesaoy, New Corella with 4 IBP lawyers, 41 STMS law students, and 469 residents. and 469 residents.

Apart from the "Tambag Legal" program, the Vice Governor has also strengthened the extension of social services through other programs such as the Vice Governor's helpdesk and Helpline, Sakay Alalay: #LibrengSakayToOVP, Shelter Assistance Program, and the partnership with the City Government of Tagum for the Project CO Eye Program.

BM Mawe's first 100 days in the SP shows remarkable achievements

The first 100 days in office of Hon. Emmanuel "Mawe" G. Pamisaran as 2nd District Sangguniang Panlalawigan Member of the Province of Davao Del Norte is signified productive with vital achievements. Known to be "Kampeon sa Kooperatiba" in his hometown Panabo City where he served as City Councilor for three (3) consecutive terms, BM Mawe Pamisaran authored Provincial Ordinance No. 2022-010, amending Provincial Ordinance No. 99-005 to

be known as the "Provincial Cooperative Development Council Ordinance of the Province of Davao del Norte". The said ordinance, which was approved on the 8th SP Regular Session last August 22, 2022, increased the budget allocation of the Council in the amount of One Million Pesos (Php 1,000,000.00) from then One Hundred Fifty Thousand Pesos (Php 150,000.00) in order to maximize and intensify the assistance and support of the Province to the cooperative development plans, programs and projects in accordance with the program of works and designs.

True to fulfilling his sworn duty as passionate legislator, BM Mawe also authored Provincial Ordinance No. 2022-011, "Institutionalizing the Provincial Livelihood Financing Assistance Programs in the Province of Davao del Norte" which was already approved on during the 15th SP Regular Session on October 10, 2022. This measure is in accordance with the mandate of the role of the Provincial Government to extend financing assistance to legitimate and qualified cooperatives, NGOs, CSOs, IP/Muslim Groups, MSMEs and individuals per approved project or program proposal of the applicant. With a very minimal interest rate, the ordinance is designed to strengthen linkages among the target beneficiaries as active partners in the pursuit of sound local and financial autonomy.

Moreover, notwithstanding the fact that the Committee on Agrarian Reform, Agriculture and Food is new to BM Mawe, the



latter authored the proposed ordinance "Institutionalizing the Provincial Agricultural and Fishery Council (PAFC) in the Province of Davao del Norte". As of this writing, the said measure is now subject for committee hearing and deliberation of the Sangguniang Panlalawigan. It aims to provide for One Million Pesos budget allocation in order to intensify the mobilization of the Provincial Agricultural and Fishery Council. This is also for the Province to fully support the agricultural and fisheries sectors and assist the implementation of national programs and projects.

It can also be recalled that on earlier date, BM Mawe delivered his privilege speech during the 8th Regular Session dated August 22, 2022 expressing his support to the plan of President BBM to venture on directly importing fertilizers from international producers and suppliers in order to reduce or lessen the cost of farm inputs of our duly accredited farmers' cooperatives and associations. BM Mawe accentuated that it is high-time for the Provincial Government to directly import from international suppliers so that the prices of fertilizers and other farm inputs may be negotiated at a lower cost which shall be retailed to the duly accredited farmers' cooperatives and associations.

In an interview, BM Mawe stressed "Rest assured na ipadayon gyud nako ang serbisyong may puso ug magbilin ako ug legasiya, sa kanunay ako maningkamot na mahimong tipik ug kabahin sa kalambuan sa atuang palanggang Probinsya."

Davao del Norte Chapter President, Hon. Devona "Bona" Hiyas Jumamil, formally took her oath of office before Vice Governor De Carlo Uy, on Tuesday, August 30, 2022 at the Sangguniang Panlalawigan (SP) Session Hall, Mankilam, Tagum City, as the newest Ex-Officio Member of the Sangguniang Panlalawigan.

Hon. Jumamil, a lawyer from Panabo City who concurrently serves as 1st Councilor of her home city, was unopposed in her bid for presidency during the PCL Davao del Norte Chapter elections held last August 12, 2022 at the Grand Regal Hotel,

induction as Sangguniang Panlalawigan official makes her the fourth (4th) female legislator in this term's roster and completes the slate of the first-ever allwomen front row in the August Chamber. Notably, this also resulted to the highest percentage of seats occupied in plenary by

women in the history of the SP of Davao del Norte comprising more than twenty-six percent (26%) thereof.

Oath-taking Ceremony was witnessed by SP officials, legislative staff as well as the family of Hon. Jumamil, namely: Atty. Vivencio Villapaz Jumamil, Mrs. Liza Hiyas Jumamil, LPT, Atty. Vinzli H. Jumamil and Ms. Veniza H. Jumamil.

"I will be firm with my commitment to serve the Province of Davao del Norte. As our Philippine Councilors Creed say, 'Public service above self...," Hon. Jumamil pledged during her first privilege speech as provincial legislator.







Hon. Oyo Uy, DavNor's youngest elected Vice Governor

Hon. De Carlo "Oyo" Uy makes a mark in the history of politics when he becomes the youngest Vice Governor elected in the Province of Davao del Norte. A natural born leader, his young age of 37 has never been a disadvantage. On the contrary, it became his edge against his competitors in the political arena. Born on January 12, 1985, he began his political career at the age of 22 when he became a City Councilor of Tagum. Politics has never been an alien concept to VG Oyo. His father is City Mayor Rey T. Uy, whose flourishing political career began over three decades ago. Apart from what he learned from his father, he humbly credits his success to his education. Although he started young, VG Oyo never took his position for granted. This can be gleaned in his initiative to provide educational assistance and scholarships to the youth in partnership with the Department of Social Welfare and Development (DSWD) and Commission on Higher Education (CHED).

Aside from education, he champions for services and programs that support the overall well-being of the province's underprivileged and socially vulnerable sector, persons with disabilities, children with special needs, youths, elders, individuals in crisis situations, among others. He is a man who also has a vast participation in women's sector being inspired by his mother, Mrs. Alma Lim Uy, who is an active Chairperson of the Tagum City Council of Women Foundation, Incorporated. In all his projects, the visionary vice governor continues to promote an open, participatory, and empowering legislative department. In believing that these are the bedrocks that the progress of the province is built upon, he never ceases in raising the bar of public service higher and continuing to pursue genuine and lasting reforms. In aiming to have his 3-point principle take form, he pushes the passage of the ordinance on "Davao del Norte Center for Children with Special Needs" and "Freedom of Information Ordinance." He believes that carefully crafted and beneficial legislation will lead towards a progressive and prosperous province.

Having earned a Master's Degree

in Business Administration at Ateneo de Davao University and having been constantly exposed to the business world, VG Oyo effortlessly infiltrated it. As the current President and CEO of Metro Gear Construction Corporation and Winterfell Ice Plant and Cold Storage, he comes from an environment that is driven by urgency to produce measurable results. This is manifested by the effective and efficient programs and activities implemented when he assumed his post.
