## EXECUTIVE ORDER No. 17

Series of 2016

## AN ORDER RECONSTITUTING THE PROVINCIAL PEACE AND ORDER COUNCIL (PPOC) OF THE PROVINCE OF DAVAO DEL NORTE

WHEREAS, Executive Order No. 309, as amended by the Executive Order Nos. 371, 320, and 379 and further amended by Executive Order No. 773 dated 05 January 2009 provides for the reorganization of Peace and Order Councils in all levels;

WHEREAS, Executive Order No. 773 amended the memberships and functions of the Council in order to address the pressing problem of insurgency and to provide the development programs and projects in remote rural and indigenous population areas affected by the communist activities;

WHEREAS, to be consistent with this amendment, Executive Order No. 013 was put into order on 12 November 2010 by then Governor Rodolfo P. del Rosario to reorganize the Provincial Peace and Order Council of Davao del Norte;

WHEREAS, with the assumption of the newly elected Governor of the Province of Davao del Norte, there is a need to reconstitute the composition of the Provincial Peace and Order Council of the Province;

**NOW, THEREFORE, I, ANTONIO RAFAEL G. DEL ROSARIO,** Governor of the Province of Davao del Norte, by virtue of the powers vested in me by law, do hereby order the reconstitution of the Provincial Peace and Order Council:

Section 1. Composition of the Provincial Peace and Order Council.

Section 2. Duties and Functions. The PPOC shall have the following duties and functions:

- a) Provide a forum for a dialogue and deliberation of major issues and problems affecting peace and order, including insurgency;
- b) Recommend measures which will improve or enhance peace and order and public safety in their respective areas of responsibility, including anti-insurgency measures;
- c) Recommend measures to converge and orchestrate internal security operations efforts of civil authorities and agencies, military, and the police;
- d) Apply moral persuasion to and/or recommend sanctions against local chief executives who are giving material and political support to the communist rebels;
- e) Monitor the provision of livelihood and infrastructure development programs and projects in the remote rural and indigenous population areas adopted to isolate them from the communist revels "Agitate/Arouse, Organize and Mobilize" and ideological, political, and organization works;
- f) Perform all other functions assigned by law, the President of the NPOC.

Section 3. Secretariat. The Provincial PPOC Secretariat shall be headed by the DILG Provincial Director with the Assistant Provincial Director and two (2) Technical Officer. The Secretariat shall manage the PPOC Operations Center.

Section 4. Repealing Clause. All prior issuances are deemed superseded by this Order.

Section 5. Effectivity. This Order shall take effect immediately upon signing hereof.
