EXECUTIVE ORDER No. 29
Series of 2016

AN ORDER RECONSTITUTING THE COMPOSITION OF THE
PROVINCIAL PAYAPA AT MASAGANANG PAMAYANAN (PAMANA)
TECHNICAL WORKING GROUP AND DESIGNATING THE FOCAL PERSON
FOR PAMANA - DILG PROJECT

WHEREAS, it is the earnest intent of the government to sustain not only peacekeeping activities but more importantly, to strengthen peace building initiatives particularly in Conflict Affected Areas (CAAs);

WHEREAS, in order to strengthen peace building, reconstruction and development in said CAAs, the government adopts a two-pronged approach, namely: (i) negotiated political settlement of all armed conflict through peace negotiations; and (ii) undertaking programs aimed at addressing the root causes of armed conflict through interventions on the ground;

WHEREAS, as component of this two-pronged approach, the Payapa at Masaganang PamayaNan or PAMANA Program was launched as a framework for intervention in conflict affected and vulnerable areas to complement the government's peace negotiation efforts as provided under Chapter 9: Peace and Security of the Philippine Development Plan 2011 to 2016;

WHEREAS, Chapter XLIII of Republic Act 10155 (FY 2012 General Appropriations Act) allocates PhP 958 Million under the PAMANA- DILG fund for projects that aim to reduce poverty and vulnerability in conflict-affected areas, improve governance and empower communities and strengthen their capacities to address issues of conflict and peace through activities that promote social cohesion;

WHEREAS, Joint Memorandum Circular No. 01, Series of 2012 issued by the Department of the Interior and Local Government (DILG) and the Office of the Presidential Adviser on the Peace Process (OPAPP) provided the guidelines in the management of the Payapa at Masaganang PamayaNan or PAMANA-DILG Fund;

WHEREAS, there are component LGUs of the Province of Davao del Norte that are previously selected and prioritized under PAMANA coverage;

WHEREAS, the objectives of the PAMANA Program are consistent and in concert with the development thrust and direction of the Provincial Government as enunciated by B.E.S.T. P.E.O.P.L.E. strategy;

WHEREAS, there is a need to reconstitute the existing PAMANA Technical Working Group following the assumption of the new Governor and the change and movement of some of its members;

NOW THEREFORE, premises considered, I, ANTONIO RAFAEL G. DEL ROSARIO, Governor of the Province of Davao del Norte, by virtue of the powers vested in my law, do hereby order the Creation of the Payapa at Masaganang PamayaNan Technical Working Group or PAMANA-TWG for brevity, including its Composition and Functions;

Section 1. Composition. The Payapa at Masaganang Pamayan Technical Working Group or PAMANA-TWG shall be composed of the following:

Section 2. Tasks and Functions. The PAMANA-TWG shall be tasked with the following:

- 2.1. Review and evaluate project proposals submitted to its level by the Local Government Units;
- 2.2. Facilitate approval by PPOC of endorsed projects of the LGUs;
- 2.3. Establish mechanisms to ensure that proposed projects are in consonance with PAMANA Program eligibility criteria as provided by JMC No. 01, Series of 2012 on the guidelines in the Management of the PAMANA-DILG Fund;
- 2.4. Conduct site visits and field validation to further assess the feasibility of proposed projects when necessary;
- 2.5. Recommend for approval or disapproval of LGU proposals;
- 2.6. Provide support to OPAPP in monitoring the implementation of the projects under the PAMANA-DILG Fund and other PAMANA funded projects; and
- 2.7. Perform such other tasks and functions necessary to carry out the purpose of this Executive Order.

Section 3. Secretariat. The Secretariat of the PAMANA-TWG shall be the **Provincial Engineer's Office**, which shall perform the following:

- 3.1. Provide secretariat assistance such as take minutes and notes, prepare journals and transcribe proceedings and maintain effective records keeping of the PAMANA Projects;
- 3.2. Coordinate intra and inter-agency activities relevant to the function of the PAMANA-TWG;
- 3.3. Facilitate the provision of resources and other logistical support; and
- 3.4. Provide other support essential in secretariat functions.

Section 4. Focal Person. The Focal Person for PAMANA-DILG Projects shall be the **Provincial Engineer** who shall perform the following:

- 4.1. Ensure the implementation of PAMANA-DILG projects in the province;
- 4.2. Ensure that the PAMANA-TWG performs their functions especially in the technical review of the project proposal.
- 4.3. Submit reports pertaining the implementation of the PAMANA Projects to the Provincial Governor, through the Provincial Administrator and subsequently submit the same to the Department of the Interior and Local Government (DILG);

Section 5. Meetings. The Members shall convene at any time or as often as necessary as determined and presided by the Chairperson or by the Vice-Chairperson, in case of absence of the Chairperson.

Section 6. Budget. Budgetary requirements for the expenses of the PAMANA-TWG shall be taken from the funds of the Provincial Peace and Order Council.

Section 7. Effectivity. This Order shall take effect immediately upon approval hereof and shall remain in full force and effect unless revoked or amended accordingly.
