EXECUTIVE ORDER No. 30
Series of 2016

AN ORDER CREATING THE PROVINCIAL ANTI-DRUG ABUSE COUNCIL OF DAVAO DEL NORTE PROVINCE AND PROVIDING ITS FUNCTIONS THEREFOR

WHEREAS, it is the policy of the State to safeguard the well-being of its citizenry, particularly the youth from harmful effects of dangerous drugs on their physical and mental well-being, and to defend the same against acts or omissions detrimental to their development and preservation;

WHEREAS, Republic Act 9165, otherwise known as the "Comprehensive Dangerous Act of 2002" was executed on 07 June 2002, repealing Republic Act 6425, otherwise known as Dangerous Drugs Act of 1972 to further pursue an intensive and unrelenting campaign against the trafficking and use of dangerous drugs, including other similar substance through an integrated system of planning, implementation and enforcement of anti-drug abuse policies, programs, and projects;

WHEREAS, to institutionalize this in the society, DILG Memorandum Circular Nos. 98-227 dated 02 December 1998; 99-226 dated 21 December 1999; and 2001-90 dated 26 July 2001 were all issued relative to the creation of Anti-Drug Abuse Councils (ADACS) in all levels of local governments; and further strengthened through the issuance of DILG Memorandum Circular No. 2003-131;

WHEREAS, to help facilitate this initiative down to the barangays of the Province, there is a need to create an Anti-Drug Abuse Council in the Provincial Level to ensure that all levels of the local government efficiently and effectively pursue its moral obligations to their constituents in its stance against illegal drugs;

NOW, THEREFORE, I, ANTONIO RAFAEL G. DEL ROSARIO, Governor of the Province of Davao del Norte and by the powers vested in me by law do hereby order the following:

Section 1. Composition. The Provincial Anti-Drug Abuse Council shall be composed of the following:

Section 2. Functions of the Council. The Provincial Anti-Drug Abuse Council shall have the following roles and functions:

1. Serve as a focal point through which various organizations and individuals work together cooperatively in the planning, implementation and evaluation of programs on drug abuse prevention;
2. Provide for an effective mechanism for the coordination of existing services and programs and those which might be developed in the immediate future;
3. Provide for a mechanism to obtain funds, volunteers, facilities, and technical expertise;
4. Meet once in a month for presentation of reports of the different task forces and other updates/concerns of the Council, and
5. Perform other related responsibilities as may be assigned by competent authorities

Section 3. Task Force. There shall be Task Forces who shall serve as implementers of all undertakings and processes of the Council. It will be supervised by an Action Officer as the overall Head.

Section 4. Roles and Functions of the Task Force

1. Livelihood & Technical Vocation

- 1.1. Design technical and vocational programs and other relative activities for the development of skills and capabilities of drug user and dependents while on rehabilitation and reintegration process;
- 1.2. Coordinate, seek partnerships with other government agencies, NGOS, and POs to engage in providing capability-building programs design to improve productivity and entrepreneurial skills of the individual while they are in the rehabilitation and reintegration process, and
- 1.3. Perform other related tasks as may be assigned by the Council through appropriate resolution.

2. **Health Services**
 - 2.1. In coordination with the Luntiang Paraiso Regional Rehabilitation Center (LPRRC), facilitate the conduct of profiling and assessment of drug users and dependents; and recommend the appropriate rehabilitation intervention for each individual;
 - 2.2. Conduct and provide regular advocacy sessions with drug users and dependents that put emphasis on the effect and implication of drug abuse to their health and well-being;
 - 2.3. In coordination with the LPRRC, monitor the individual progress of each individual as to their response to the health and rehabilitation interventions;
 - 2.4. Coordinate, seek partnerships with the Department of Health and other NGOs, and POs for the delivery of basic health services and programs for the LPRRC, and
 - 2.5. Perform other related tasks as may be assigned by the Council through appropriate resolution.
3. **Social and Physical Fitness**
 - 3.1. In coordination with LPRRC, design extensive holistic rehabilitation and reintegration programs that put emphasis to personal and social development and responsibility of the drug user and dependent as a member of the community;
 - 3.2. In coordination with LPRRC, coordinate and seek partnership with the Department of Social Welfare and Development, the Department of Health, and other NGOs and POs for the conduct of various related social development projects and activities, such as outreaches and community immersions, and
 - 3.3. Perform other related tasks as may be assigned by the Council through appropriate resolution.
4. **Spiritual and Moral Recovery Program**
 - 4.1. Design appropriate various enriching spiritual and moral recovery programs, such as outreaches and community immersions with drug user and dependents and their family;
 - 4.2. In coordination with LPRRC and the barangay, facilitate the conduct of spiritual and moral recovery program in the barangays where drug users and dependents belong;
 - 4.3. Facilitate the creation of an in-house and barangay-based support group or mentors group to provide readily available counseling and support system for the immediate need of the drug user and dependents or their family, and
 - 4.4. Perform other related tasks as may be assigned by the Council through appropriate resolution.
5. **Rehabilitation Services**
 - 5.1. In coordination with LPRRC, DOH, and DSWD, coordinate and seek support from the national government to continually improve and sustain the various rehabilitation services of the LPRRC;
 - 5.2. Coordinate with the barangay as to extending the rehabilitation services of the LPRRC to non-residents;
 - 5.3. In coordination with LPRRC, facilitate the monitoring of the delivery of various rehabilitation services of the facility through the conduct of periodical assessment and inspection of the facility to eliminate nuances, if any.
 - 5.4. Provide the PADAC Chairperson a terminal report of the assessments undertaken, and
 - 5.5. Perform other related tasks as may be assigned by the Council through appropriate resolution.
6. **Finance (Ways and Means)**
 - 6.1. Provide for a mechanism to obtain funds through partnerships and agreements with other government agencies, NGOs and POs;
 - 6.2. Take charge in the control of funds relative to the operations of the Provincial Anti-Drug Abuse Council;
 - 6.3. Provide financial report to the members of the PADAC Council, and
 - 6.4. Perform other related tasks as may be assigned by the Council through appropriate resolution.
7. **Sports and Physical Fitness**
 - 7.1. In coordination with LPRRC and the barangay concerned, design appropriate sports and physical fitness program for both residing and non-residing drug users and dependents under the rehabilitation program;
 - 7.2. In coordination with Provincial Health Office, conduct regular health consultations for drug users and dependents;
 - 7.3. Coordinate with Disaster Preparedness Task Force as to integrating disaster preparedness training in the physical fitness activities, and
 - 7.4. Perform other related tasks as may be assigned by the Council through appropriate resolution.
8. **Disaster Preparedness Training**

- 8.1. In coordination with the PGO-PDRRMD, conduct disaster preparedness training for LPRRC and the barangay; and conduct assessment for the recruitment of potential barangay emergency responders;
- 8.2. Coordinate with Sports and Physical Fitness Task Force as to integrating disaster preparedness training in the physical fitness activities;
- 8.3. Perform other related tasks as may be assigned by the Council through appropriate resolution;

9. Security

- 9.1. Closely coordinate with the PNP as to the provision of security measures and personnel during PADAC activities in the barangay;
- 9.2. Maintain copy of list of drug users and dependents in the barangay, and
- 9.3. Perform other related tasks as may be assigned by the Council through appropriate resolution.

10. Education

- 10.1. In coordination with LPRRC and barangays, conduct lectures and information and education campaign in the barangays on the hazards and ill-effect of illegal use of dangerous drugs;
- 10.2. In coordination with Livelihood & Technical Vocational Task Force, conduct short-course trainings to develop capability and entrepreneurial skills of drug users and dependents, and
- 10.3. Perform other related tasks as may be assigned by the Council through appropriate resolution.

11. Legal Concerns

- 11.1. In coordination with the Education committee, conduct lectures and seminars on laws and ordinances concerning the prohibition of illegal drugs both in the international and local context;
- 11.2. Provides free legal advice and consultation for drug users and dependents in conflict with the law;
- 11.3. Prepares contracts, agreements, and other legal documents required in the various undertakings of the Council, and
- 11.4. Perform other related tasks as may be assigned by the Council through appropriate resolution.

Section 5. Secretariat. The Provincial Social Welfare Development Office (PSWDO) - Community Affairs Division shall serve as the Secretariat to the Council, with the following functions:

- 5.1 Provide secretarial assistance such as take minutes and notes, prepare journals and transcribe proceedings of the PADAC Meetings;
- 5.2 Coordinate activities relevant to the functions of the various Task Forces;
- 5.3 Facilitate the provision of resources and other logistical support;
- 5.4 Facilitate the conduct of the Council Meeting who shall meet once in every month, and
- 5.5 Provide other support essential in secretarial functions.

Section 6. Support and Funds

1. The Provincial Government of Davao del Norte, subject to the availability of funds, shall support the undertakings of the Council;
2. The Council is likewise authorize to seek and solicit assistance from the professional, civic, religious and the mass media to augment government support, provided, that all assistance coming from these sectors shall be deposited to the Provincial Treasurer as trust fund of the Council, and
3. The Council shall manage the funds as it may deem proper for the attainment of the objectives of this Executive Order, subject to the accounting and auditing rules and regulations.

Section 7. Repealing Clause. The Executive Order 20 series 2016 and all other previous related local issuances inconsistent herewith are hereby repealed accordingly.

Section 8. Effectivity. This Order shall take effect upon signing hereof.
