EXECUTIVE ORDER NO. 43 Series of 2016

AN ORDER RECONSTITUTING THE PROVINCIAL DEVELOPMENT COUNCIL OF **DAVAO DEL NORTE**

WHEREAS, Book I, Title VI, Section 106 of Republic Act No. 7160, otherwise known as "Local Government Code of 199" provided that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian;

WHEREAS, for the abovementioned purpose, the development council at the provincial, city, municipal, or barangay level shall assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction;

WHEREAS, that the reconstitution of the Provincial Development council is in line with the intent of the Department of the Interior and Local Government (DILG) Memorandum Circular No. 2007-114, specifically on item 6 thereof on the Reconstitution and Strengthening of the Local Development council as Mandated Planning Structure;

WHEREAS, with the fresh mandate of the newly elected public officials, there is a need to reconstitute the Provincial Development Council;

NOW THEREFORE, I, ANTONIO RAFAEL G. DEL ROSARIO, Provincial Governor, Province of Davao del Norte by virtue of the powers vested in me by Law, do hereby order the following:

SECTION 1. COMPOSITION. The composition of the council is as follows:

SECTION 2. FUNCTIONS. The functions of the Provincial Development Council are as follows:

- 1. Formulate long & medium term and annual socio-economic development plan and policies;
- 2. Formulate medium term and annual investment program;

- 3. Appraise and prioritize socio-economic development programs and projects;
- 4. Formulate local investment incentives to promote the inflow and direction of private investment capital;
- 5. Coordinate, monitors and evaluates the implementation of development programs and projects; and
- 6. Perform such other functions as may be provided by Law or competent authority.

SECTION 3. MEETINGS. The Provincial Development Council shall meet at least once every six months or as often as may be necessary;

SECTION 4. CREATION OF EXECUTIVE COMMITTEE WITHIN THE COUNCIL. The composition of said committee is as follows:

SECTION 5. FUNCTIONS OF THE PDC-EXECUTIVE COMMITTEE.

- 1. Ensure that the decision of the council are faithfully carried out and implemented;
- 2. Act on matters requiring immediate attention or action by the council;
- 3. Formulate policies, plans and programs based on the general principles laid down by the council; and
- 4. Act on matters that maybe authorized by the council.

SECTION 6. THE SECRETARIAT. The Secretariat of the Council shall be headed by the Provincial Planning and Development Coordinator, and shall be supported by the staff of the Provincial Planning and Development Office. The Secretariat shall be responsible in providing technical support documentation of the proceedings and preparation of reports and such other assistance as may be required in the discharge of its functions.

SECTION 7. REPEALING CLAUSE. All other orders or issuances which are inconsistent hereof are repealed or modified accordingly.

SECTION 8. EFFECTIVITY. The Executive Order shall take effect immediately.

This has reference for legal opinion on the proposed Executive Order re: An Order Reconstituting the Provincial Development Council of Davao del Norte to be issued by Hon. Antonio Rafael G. Del Rosario, Governor, Province of Davao del Norte.

The reconstitution of the Provincial Development Council is in line with the purpose of Section 106, par. a of Republic Act 7160, otherwise known as "Local Government Code of 1991", which provides that each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian. For this purpose, the development council at the provincial, city, municipal, or barangay level, shall assist the corresponding sanggunian in setting the direction of economic and social development, and coordinating development efforts within its territorial jurisdiction.

In addition, under par. c of Section 106 of the same Act, the membership of the Provincial Development Council has been enumerated. Corollary thereto, the functions of the Provincial Development Council have been stipulated under Section 109 of the same Code.

However, it is suggested that the Preambular Whereas Clauses should incorporate the following in lieu of what have been stipulated in the draft Executive Order:
