AN ORDER AMENDING EXECUTIVE ORDER NO. 37, SERIES, "RECONSTITUTING
PROVINCIAL ADVISORY COMMITTEE (PAC) MEMBERS

WHEREAS, Executive Order No. 37, Series of 2016 was issued on 21 September 2016 to reconstitute the Provincial Advisory Committee (PAC), its members and providing functions therefore;

WHEREAS, the Department of Social Welfare and Development (DSWD) came up with the strategy on convergence to harmonize and strengthen the delivery of the programs and services implemented in the Province with the Provincial Action Team (PAT) spearheading the program implementation;

WHEREAS, the Pantawid Pamilyang Pilipino Program is the entry point of the strategy representing the protection aspect as it addresses risks and vulnerabilities related to health and education – factors which are known to influence the cycle of poverty in the country. The said program is complemented by the transformative nature of KALAHI-CIDSS-National Community Driven Development Program (KC-NCDDP), which has been proven to increase the capacity of the people to engage in development process through the Community-Driven Development (CDD) approach. The promotive aspect of Sustainable Livelihood Program (SLP) complements services/implementation with other Core Social Protection Programs through Community-Driven Enterprise (CDE) process, using the concept of resource-based and market-driven livelihood activities and employment facilities;

WHEREAS, the DSWD strategically pool together the expertise and resources of the department to achieve greater impact in poverty reduction by addressing the multi-dimension causes of poverty, common understanding, common commitment, common resolve – convergence strategy;

WHEREAS, during the regular PAC meeting held on 19 October 2016, it was approved that PAC members shall be amended so that the committee shall only compose of the head of the partner offices/agencies as the regular members;

NOW, THEREFORE, I, ANTONIO RAFAEL G. DEL ROSARIO, Provincial Governor of Davao del Norte Province, by virtue of the powers vested in my by law do hereby order the following amendments:

Section 1. Composition. The Provincial Advisory Committee shall be composed of the following:

Section 2. Roles and Responsibilities. The PAC shall perform that following roles and responsibilities, to wit:

1. Oversee and supervise the over-all implementation of the convergence programs of DSWD in the Province of Davao del Norte;
2. Conduct regular meeting and consultation to discuss Convergence Updates and other Social Welfare Programs funded by DSWD and implemented in the Province;
3. Deliberate issues, gaps, and concerns confronting the key players in the program/project implementation and come up with a common resolve to ensure harmonization;
4. Provide technical, financial, and other logistics support to the cities/municipalities in the implementation of programs/projects in coordination with partner-agencies, if needed/required;
5. Monitor and coordinate with concerned partners (NGAs, NGOs, POs, and CSOs) on their supported project status, ensuring convergence of resources (human, financial, physical, etc.);
6. Ensure the utilization of Social Welfare and Development Indicators (SWDI) results to determine levels of well-being on targeted poor households and to make sure that the SWDI gaps identified are responded accordingly.

Section 3. Secretariat. The Secretariat shall be responsible for the over-all coordinative efforts undertaken by the Provincial Advisory Committee (PAC).

Section 4. Meeting. The PAC shall meet regularly once in every year quarter and may convene if the need arises.

Section 5. Repealing Clause. Executive Order No. 37, Series of 2016 and other previous related local issuances inconsistent herewith are hereby repealed accordingly.

Section 5. Effectivity. This order shall take effect immediately upon signing thereof.
