JUBAHIB**, hereinafter referred to as the **PROCURING ENTITY**;

ASS., INC., a registered workers' association under the Securities and Exchange Commission with Registration No. CN200429291 and business address at Sitio Nueve, Purok 5, San Miguel, Sto. Tomas, Davao del Norte, duly represented by its Chairperson, **SATURNINO D. SIMBAJON**, hereinafter referred to as the **CONTRACTOR**.

WITNESSETH THAT:

WHEREAS, the Procuring Entity is a local government unit mandated to provide infrastructure facilities to service the needs of the residents of the province and which funded out of provincial funds including, but not limited to, provincial roads and bridges; intermunicipal waterworks, drainage and other similar facilities;

WHEREAS, pursuant to Section 53.12 of IRR of RA 9184 and GPPB Resolution No. 03-2013 dated January 21, 2013, it recognize the Community Participation and authorize the Procuring Entity to grant the rural community-based contractors in the procurement of goods and services and simple infrastructure projects through negotiated agreement particularly the rural road maintenance in some areas of the Province of Davao del Norte;

WHEREAS, the Procuring Entity under General Fund CY 2020, intends to apply the sum of ONE HUNDRED THIRTY-ONE THOUSAND SIX HUNDRED EIGHT PESOS AND THIRTY-SEVEN CENTAVOS (PHP 131,608.37) being the Approved Budget for the Contract (ABC) for the Contract – Community Based Road Maintenance Contracting (CBRMC) and the bidding was conducted for the purpose of maintaining various Provincial Roads and Bridges – 11DAN123 BACALI CASIG-ANG LIBERTAD, governed by Republic Act 9184 otherwise known as "The Government Procurement Reform Act";

WHEREAS, upon the opening of negotiated procurement and after proper evaluation of the criteria and standards set forth by law, the Bids and Awards Committee (BAC) through BAC Resolution No. 170, series of 2020, resolved to declare the Contractor as the Single Calculated and Responsive Bidder to undertake the afore-cited Project;

WHEREAS, the Contractor is willing to undertake and implement the project in the manner provided under this contract, existing laws and/or upon the request by the Procuring Entity.

NOW THEREFORE, for and in consideration of the foregoing premises, the parties hereto agreed, as by these presents, do hereby agree to be bound by the following terms and conditions, to wit:

I-CONTRACT

This agreement is an infrastructure project between the PROVINCIAL GOVERNMENT OF DAVAO DEL NORTE and SAN MIGUEL DUJALI IRR. ASS., INC., with approved project pursuant to PR No. 20010842, hereinafter called the "Community-Based Road Maintenance Contract".

The project consists of Contract - Community Based Road Maintenance Contracting (CBRMC) for the maintenance of various Provincial Roads and Bridges - 11DAN123 BACALI CASIG-ANG LIBERTAD.

Progress billing will be made every quarter.

II-DURATION

The intended project should be done within six (6) months from the time the Notice to Proceed was issued by the Procuring Entity and received/acknowledged by the Contractor.

III-CONTRACT PRICE

The Provincial Government of Davao del Norte has an Approved Budget of the Contract (ABC) of ONE HUNDRED THIRTY-ONE THOUSAND SIX HUNDRED EIGHT PESOS AND THIRTY-SEVEN CENTAVOS (PHP 131,608.37). The Contractor submitted a bid quotation of ONE HUNDRED THIRTY-ONE THOUSAND PESOS (PHP 131,000.00).

IV-GENERAL TERMS AND CONDITIONS

The contractor shall assume full responsibility for the contract work from the time project construction commenced up to a reasonable period taking into consideration the scale and coverage of the project from its final acceptance by the Procuring Entity. In case of failure or refusal to comply with this mandate, the government shall undertake such repair works and shall be entitled to full reimbursement of expenses incurred therein upon demand. (Section 62(b) - Warranty of Republic Act 9184 as further defined in the Revised Implementing Rules and Regulations).

The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
