The procuring entity shall be allowed to make adjustments in the units/volume to be delivered per type of product to conform to the remaining amount in the total contract price.
3. The supplier shall be responsible to dispense fuel to **BM Shirley Belen R. Aala** vehicles only and ensure that issued fuel will not exceed PO allocation.

10. Additional fund allocation due to supplemental budget, augmentation shall follow the usual procedures of procurement.




