## **RESOLUTION NO. 16**

SERIES OF 2013

RECALLING THE INVITATION TO BID FOR THE PROCUREMENT OF GOODS PARTICULARLY BID No. B20130011 (ID/PR. No. 13020453) AND CANCELLING THE DATE OF ITS OPENING OF BID PROPOSAL.

Whereas, the Bids and Awards Committee has published its Invitation to Bid as required under IRR of RA 9184 in PhilGEPS, Agency Website and Newspaper of nationwide circulation last February 22, 2013;

Whereas, during its pre-bid conference held last March 1, 2013, vital issues and concerns were raised by those who are interested to participate in the bidding, particularly on the specifications of the items/goods to be procured since what are indicated lack the detailed technical specifications and parameters which they find it difficult to prepare and submit their proposals;

Whereas, the members of the Bids and Awards Committee, found the issues and concerns raised by the prospective bidders' representatives valid and meritorious, hence the matter has to be addressed in order to prevent difficulties during the detailed evaluation and comparison of bids particularly on the technical specifications of the goods;

Whereas, taking cognizance of the issues and concerns raised during the Pre-bid conference and in order to deter complications during the conduct of evaluation and post-qualification procedures, the BAC called this special meeting for resolution;

Whereas, after reviewing on the bid documents, and the period for which requisitioning office has to thoroughly review and rectify the technical specifications and parameters, the members of the committee find it not technically feasible to proceed with its opening of the bid on the stated date considering the requirement set forth in Section 22.5 of IRR of RA 9184;

Now, therefore, it resolved, as it is hereby resolved, to recommend to the Governor as Head of the Procuring Entity, the recall of the Invitation to Bid for the Procurement of Goods, particularly, Bid No. B2013130011 (ID/PR No. 13020453) and cancel its Opening of Bids as stated thereof in order to review and rectify the technical specifications and parameters of the goods based on the reasons cited above.

Further resolved to recommend to the Head of the Procuring Entity to approve the recall of the said Invitation to Bid particularly, Bid No. B2013130011 (ID/PR No. 13020453) and cancel its bid opening.
