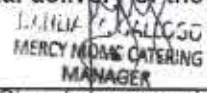
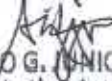
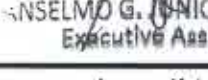
FOOD AND CATERING SERVICES

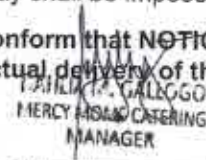
